



Vide notification No. ECI/PN/23/2024 dated 16.03.2024 of the Election Commission of India, Lok Sabha Election 2024 has been declared for various constituencies of Madhya Pradesh. In pursuance thereof, Government of Madhya Pradesh, General Administration Department, Bhopal has issued notification No. 3-03/2019/1/4 dated 26.03.2024, declaring public holiday in the various Lok Sabha constituencies of Madhya Pradesh.

Vide circular no. D/488 dated 22.01.2015 issued by High Court of Madhya Pradesh, all the Principal District Judges have been authorized to issue a notification for declaring holiday for their respective districts/area which goes for poll on account of Lok Sabha, Vidhan Sabha, Local Bodies, Municipal Election etc. In compliance of the above circular, Principal District Judges of the respective district have declared public holiday on the date of polling for the courts falling under their jurisdiction, within the respective constituency of the Lok Sabha.

Hence, in partial modification of Registry notification no. C/1526 dated 08.02.2024, Hon'ble Chief Justice has been pleased to declare 20.07.2024 (Saturday) as a court working day for the District Judiciary in lieu of the holiday so declared by the Principal District Judges on account of Lok Sabha election for their respective district/area.


