As directed a communication has been received from e-Committee SCI whereby, it has been proposed to develop and train new Master Trainers among hidden Staff to increase. been proposed to develop and train new Master Trainers among Judicial Officers/Court Staff to increase the existing strength of Master Trainers. The Chairperson has also directed to prepare an exclusive list of Judicial Officers and Court Staffs with technical qualifications. Pursuant to the same, nomination of Judicial Officers/Court Staffis being sought under the following categories:

> Category A-List of Judicial Officers with technical qualification*: (ECMT-JOTQ) Category C- List of members of Court Staff with technical qualification*: (ECMTCSTQ)

> Under this category, a Judicial Officer/Court Staff possessing *technical qualification in computers (E.E; B.Tech, B.Sc (CS), MCA, M.Tech) or computer related fields Bachelor/Masters Degree in Data Science, Artificial intelligence etc. Diploma or certificate course need not be included under Technical qualification;

> List of Judicial Officers with technical qualification (as prescribed in Annexure A) and of the Court Staff with technical qualification (as prescribed in Annexure C)

> List of Judical Officers with technical qualification (as prescribed in Annexure A) and of the Court Staff with technical qualification (as prescribed in Annexure C) kindly be sent to the High Court on or before 25.10.2021.

Category B- List of Potential Master Trainer Judicial Officers (ECMT-JO) Category D- List of Potential Master Trainer Court Staffs (ECMT-CS)

Some Judic a! Officers/ members of Court Staff, although not holding a technical qualification, may be tech-savvy, well versed with technological updates, and proactive in using ECT tools in day to day court administration. Such officers may be considered for under Categories B & D. The nominated Judicial Officers/ Court Staff must be willing to be a trainer and take up various activities of the e Courts Project. Hence the willingness of the concerned Judicial Officers/Staffs may also be obtained before sending their names.

Under Category B & D, each High Court may nominate 2 persons per district. The High Courts are at liberty to nominate more persons for geographically larger and demographically diverse districts according to the needs of the respective High Courts;

For instance, if there are 25 districts in a State and 2 persons are nominated from each district, the total nominees would be 50 (25 X 2). In case of non availability of potential nominees from a particular district, the total number of nominations can be covered by nominating persons from other districts. In the case of larger districts, the respective High Courts are at liberty to nominate more than 2 persons, according to the needs of each High Court;

While making nominations, an effort must be made to cover Judicial Officers from all cadres, that is, preferably 15% of the nominees must be District Judges, 25% must be Senior Civil Judges and 60% must be Junior Division Judges. Similarly, while nominating members of Court Staff, all cadres must be covered, that is, preferably 15% of the nominees must be Court Staff from administrative While making nominations, an effort must be made to cover Judicial Officers from all cadres, that is, preferably 15% of the nominees must be District Judges,25% must be Senior Civil Judges and 60% must be Junior Division Judges. Similarly, while nominating members of Court Staff, all cadres must be covered, that is, preferably 15% of the nominees must be Court Staff from administrative

While considering nominees under Category A and C, the Judicial Officer/Court Staff must possess a Bachelor's degree/Master's degree in Computer Science/Computer Technology or other computer-related subjects like Data Science, Artificial Intelligence, Hardware, Networking, etc. Judicial Officers/Court Staffs holding a diploma in computers or having completed certification courses in computers may be nominated under Category B and D;

The nominated Judicial Officers/ Court Staffs will undergo intensive training to become Master Trainers. Master Trainers will thereafter be entrusted to hold eCourt related training and awareness programmes for various stakeholders at the taluk, district, and State level. The date, time, and schedule of the training will be intimated in due course.

It is request to share the information on before 25-10-2021, so that the same may be furnished to the eCommittee Supreme Court of India timely.

In view of the above, I request you to kindly co-ordinate with your Judge and send a list of potential Master Trainers to the High Court on or before 25.10.2021 such that it may be placed before the Chairperson of the eCommittee.
