(B) Practical Examination for computer and typing: -

Practical Examination shall consist of **two** Parts. The Parts and Marks shall be as under: -

(i) Direct dictation typing: -

Direct dictation typing shall be direct typing on the dictation of around <u>350</u> words in <u>10</u> minutes. This test shall be of 10 Marks. The candidate shall has to type the dictation and <u>0.1</u> mark shall be deducted for each mistake. The candidates shall be permitted to use their own keyboards.

(i) Matter typing: -

There shall be a Matter typing (Hindi) test immediately after direct dictation typing test which shall be of around 300 words typing. This test shall be of total **10 Marks** and and **0.1** mark shall be deducted for each mistake. The candidates shall be permitted to use their own keyboards.

8- Valuation of papers:
