उपरोक्त विषयान्तर्गत संदर्भित परिपत्र के द्वारा माननीय मुख्य न्यायाधिपति महोदय उच्च न्यायालय मध्यप्रदेश जबलपुर द्वारा संदर्भित पूर्व ज्ञापन के अग्रसरण में जारी परिपत्र क क्यू—9 दिनांक 24.04.2020 के निर्देश जारी किये किये है। जिसका कियात्मक भाग (Operative Part) अग्रलिखित है —

"Hon'ble the Chief Justice has been pleased to direct that physical presence of Advocates Litigants and all the stakeholders should strictly be prohibit in those court rooms where presiding officer and staffs are discharging their duties.

It is further directed that during the lockdown period only Advocates accused and necessary parties shall be permitted to enter into the court premises and as per requirement he/she will be authorized to take part, one by one, in the hearing through video conferencing. Meaning thereby that only one Advocate or/ and his senior advocate shall be permitted to enter into V.C. room."

साथ ही V.C. room. में प्रवेश के समय पूर्व में माननीय उच्च न्यायालय केन्द्रीय शासन एवं राज्य शासन द्वारा समय समय पर जारी निर्देश के अनुसार Precautionary measures(Social distancing sanitization etc.) का पालन अनिवार्य



होगा।

यह भी निर्देशित किया जाता है कि परिपत्र में दिये गये निर्देशों का कठोरता से पालन सुनिश्चित करें। निर्देशों का अपालन करने की स्थिति में आवश्यक वैधानिक कार्यवाही की जा सकेगी।

# HIGH COURT OF MADHYA PRADESH

## CIRCULAR

No. Q-9

Jabalpur dated 24th April 2020

To,

All District and Sessions Judges, State of Madhya Pradesh,

Sub.:COVID-19 - Nationwide lock down - Directions of Hon'ble the Chief Justice.

**Ref.**:Order No.Q-5 dated 25.03.2020 and Video Conferencing guideline for the District Courts during the lock down period dated 20.04.2020.

Kindly refer to the above Circular and Guidelines by which it was directed that hearing of the cases, in lock down period, ought to be only through Video Conferencing and restricted to the cases only of **urgent nature**, which is to be decided by the concerned District Judge or in case of Family Courts matter, concerned Principal Judge of Family Court. However recently it has been experienced that at many places in the state of Madhya Pradesh Court Rooms are being opened for hearing which are overcrowded and the direction of social distancing is not fallowed. That is not only in violation of the directions but also dangerous for the society at large.

The aforesaid state of affairs is contravention of the guidelines and directions issued by the High Court from time to time. Hon'ble the Chief Justice has expressed deep concern over it and keeping in mind all the situations his Lordship has been pleased to direct that the physical

presence of Advocates, Litigants and all the stakeholders should strictly be prohibit in those court rooms where presiding officer and staffs are discharging their duties.

It is further directed that during the lockdown period only Advocates, accused and necessary parties shall be permitted to enter into the Court premises and as per requirement he/she will be authorized to take part, one by one, in the hearing through video conferencing. Meaning thereby that only one Advocate or/ and his senior advocate shall be permitted to enter into the V.C. room.

At the time of hearing through V.C., in the V.C. room of the Court campus, all precautionary measures shall be taken as directed by the High Court of M.P. and Central Government as well as by the State Government from time to time. Moreover the Advocates should be encouraged to conduct V.C. from their home or office and avoid any kind of hazard during lockdown period of COVID-19.
