#### 1. Instructions to the Tenderers:

- I. Tenders are invited Through Government Online Tender portal https://mptenders.gov.in only from the Reputed/Authorized Vendors/ Agencies for Mechanized Cleaning Services, <u>District Court Building</u>, <u>Extended Court Building</u>, <u>Pocso Court Building and Special Court building's 2 Courtrooms situated in the Premises of District Court Morena(M.P.)</u>. The last date of tender submission is 14/10/2025 till 5:00 P.M. The tender shall be opened on 15/10/2025 at 05:00 P.M. Offline tender will not be considered.
- II. Before filling the tender, the tenderer must observe the entire work area related to the tender work by obtaining written permission from the Office of the Principal District & Sessions Judge, Morena in coordination with District Nazir, otherwise it will be assumed that he has obtained proper information about the entire work areas concerned. Nevertheless, he will not be able to take any objection in this regard at the subsequent stage.
- III. Tender relates to the "Mechanized Cleaning Services, District Court Building, Extended Court Building, Pocso Court Building and Special Court building's 2 Courtrooms situated in the Premises of District Court Morena(M.P.) The Tenderer is required to execute the Contract by accepting the conditions mentioned at List-1, List-2, List-3 and List-4 otherwise he shall clearly specify what items /Manpower/Machines/Services will not be covered under the services. All the remaining items/services shall be treated as covered under the operation services.

#### 2. Period of Contract:

The contract shall be initially for the period of **one year** from the date of agreement which can be extended further on mutual agreement subject to satisfactory performance of the contractor and will also depend upon the price trend for the services/products in the market on the date of extension.

#### 3. Scope of the Work:

- 3.1 The place of performance will be the <u>District Court Building</u>, <u>Extended Court Building</u>, <u>Pocso Court Building and Special Court building's 2 Courtrooms situated in the Premises of District Court Morena(M.P.)</u> The tender relates to the Mechanized Cleaning Services for the premises District Court, Morena (M.P.)
- 3.2 It will be duty of the Contractor/Service Provider to have the credentials of the 12 Service Persons/Operator duly verified & certified and the personnel engaged for services are required to properly dressed with photo ID's and the same to be provided by the Contractor/service provider.
- 3.3 The Mechanized Cleaning Services of the proposed areas shall include cleaning as per the "LIST-1 (ANNEXURE-P1)" in the Premises of <u>District Court Building</u>, <u>Extended Court Building</u>, <u>Pocso Court Building and Special Court's building 2</u>

  <u>Courtrooms situated in the Premises of District Court Morena(M.P.)</u>
- 3.4 Adequate number of cleaning machines mentioned at "LIST-2(ANNEXURE-P2)" with qualified operators shall be deployed for Mechanized Cleaning for the places where Mechanized Cleaning is feasible and adequate number of service personnel/manpower shall be employed for cleaning of the places where Mechanized Cleaning is not feasible/possible.
- 3.5 The Mechanized Cleaning Services of the proposed areas shall includes the MACHINES as per "LIST-2 (ANNEXURE-P2)" and the schedule of work for mechanized cleaning of the proposed are has been mentioned at "LIST-3 (ANNEXURE-P3)" the Contractor is required to perform his daily routine work as per the List-3.
- 3.6 The Contractor shall arrange wet and dry cleaning of all the areas as per List enclosed" everyday. It shall be the duty of the Contractor to dispose the garbage as per the rules. The wet cleaning shall include the cleaning by use of proper soap, phenyl and other cleaning chemicals of standard and reputed make mentioned at "LIST-4 (ANNEXURE-P4)". The instruction of the Office of the Principal District & Sessions Judge, Morena in this regard shall be final and binding on the contractor.
- 3.7 Any other work of similar nature assigned by the Principal District & Sessions Judge, Morena will be binding on the Contractor.
- 3.8 The vendor shall depute one sweeper/cleaner at every set of Gents and Ladies public Toilets throughout the working hours on every working day, These sweepers, cleaners shall ensure regular cleaning and sanitation 05 times of the day of public toilets.
- 3.9 Place of performance for cleaning of areas includes every section, every Court Room & adjacent chambers with their toilets, both judicial lockups, corridors, common Toilets, dry moping of the entire premises, stairs of every building, water dispenser platforms, parking area, Chambers of the Court Manager, Administrative Officers/Deputy Administrative Officers, Cleaning of Dustbean and building's roof

#### 4. Terms and conditions:

- 4.1 Required number of Mechanized Cleaning machines shall be provided by the Contractor as per "LIST-2 (ANNEXURE-P2)" and Consumable items as per "LIST-4 (ANNEXURE-P4)".
- 4.2 Cost of cleaning material and other consumables like soap, phenyl, room freshener, brush utensils, floor wiper, etc. shall be borne by the contractor. Cleaning material of reputed company shall only be used. The machines shall be kept in serviceable condition by the contractor.
- 4.3 The initially cleaning work of any particular day shall, under all circumstances, be finished by the Contractor on the same day or before 10.00 am and throughout the day shall continued as required during the working hours. If the work is not finished on the same day, a penalty of Rs. 2500/-per day shall be livable from the amount payable to the Contractor. If any machine remains out of order for a continuous period of more than three days without replacement/repair of the operator/service person of the Contractor remains absent for three days continuously, an amount of Rs. 2500/- per day per machines/per person shall be leviable and the same shall be deducted from the amount payment to the contractor.
- 4.6 Even the penalty amount may be exceeded up-to 75% of the month payment, may be imposed, if the contractor is regularity committing the irregularity in maintaining the cleanliness in the proposed areas/court premises.
- 4.7 The Contractor shall report immediately whenever called by the Nazarat Section, of the District Court, Morena on receiving telephone or message to attend the complaints with regard to the cleaning works services in lieu of the contract provisions/clauses.
- 4.8 Sufficient stock of consumables like soap, phenyl, room freshner, brush, utensils, floor wiper, etc. for a month should be maintained and shown to the Incharge Nazarat Section or Official deputed for the purpose in the first week of every month or whenever asked.
- 4.9 No private work shall be performed by the cleaning persons/ machines during the subsistence of the contract and the Contractor/vendor shall not be permitted to take out the machines/equipments outside the premises of District Court.
- 4.10 The Contract may be extended for a period of one month, or which may be exceeded upto 6 months, if the performance has found satisfactory and the future contracted formalities exceed to be conducted. It shall be terminable by the Principal District & Session's Judge, Morena at any time without notice and mentioning the reason. Extension of contract shall be purely at the discretion of Principal District & Sessions Judge, Morena.

- 4.11 Space for keeping the machines and electric power and supply line shall be provided by the Principal District & Sessions Judge, Morena. The Contractor has to bear the cost of installation of additional plug points, if required.
- 4.12 The cleaning work shall be start functioning within a week, after receiving of the work order.
- 4.13 The Contractor shall maintain a register mentioning the work and duties performed in the prescribed proforma which shall be verified by the Officer Incharge, Nazarat or any other Officer/official deputed by Principal District & Sessions Judge, Morena in this behalf, at the end of every week.
- 4.14 The machines/instruments shall be operated only by the Operator(s), duly authorized by the Contractor and verified by the District Registrar, District Court Morena to maintain the security of the District Court, Morena. All sweepers/Cleaners/Machine Operators shall wear the uniform provided by the Contractor and shall conspicuously wear the identity Card signed by the District Registrar.
- 4.15 The tender will be opened in the office of the Principal District & Session Judge, Morena. One representative of the bidder may remain present. Tender will be finalized after considering the proposals. All tenderer or any of the tenderer may be called for further clarification before considering his/their proposal.
- 4.16 The Principal District & Session Judge, Morena shall have absolute right to select/ reject any quotation/quotationer for Mechanized Cleaning services on the basis of rate, quality services proposed in the tender and working experience of the bidder.
- 4.17 The applicant is required to submit all technical Brochure(s) of the machines(s) proposed to be installed at District Court, Morena
- 4.18 The Principal District & Sessions Judge, Morena has holding the right of accepting or rejecting any and all tenders without specifying any reason(s) thereof. The Principal District & Sessions Judge, Morena, under no obligation has to accept the only lowest tender.
- 4.19 There are no obligations on the part of the Principal District & Sessions Judge, Morena to inform the unsuccessful tenderer of the outcome of the tender process and reasons for rejection of the tender.
- 4.20 The successful contractor shall forthwith engage/depute service persons/operators to operate the machines for cleaning in the District & Sessions Court, Morena.
- 4.21 It shall be mandatory for the Contractor to conduct routine inspection to maintain the cleanliness in perfect sanitized condition and to submit the routine inspection reports on monthly basis duly verified by the OIC Nazarat Section, Morena to the Office of Principal District & Sessions Judge, Morena.
- 4.22 In case of pecuniary loss suffered due to improper service by any of the users/beneficiaries, the Principal District & Sessions Judge, Morena will have the right to forfeit the security deposit and in case of security deposit falls short to match the pecuniary loss being insufficient such balance will be recovered from the payments due to the Contractor and shall leads to the legal action, if required.
- 4.23 A surprise inspection shall be conducted by the officer's deputed by or the Principal District & Sessions Judge, Morena to ascertain the performance of the service persons/operators and in lieu to their work.
- 4.24 Rates offered in the tender will not be enhanced during the period of contract in any

condition

- 4.25 The rates finally approved/accepted by the Principal District & Sessions Judge, Morena and it shall be valid for the specified contract tenure and there were no upward revision will be allowed under any circumstances/conditions whatsoever.
- 4.26 Under no circumstances, the successful firm appoint any sub-contractor or sub-lease of the contract. If it is found that the Contractor has violated any conditions, the contract will be terminated forthwith without any notice, by Principal District & Sessions Judge, Morena.
- 4.27 The successful tenderer will be required to furnish the security **deposit of 20% of the contract value within** 7 (Seven) days from the date of acceptance of the tender.

  The security deposit shall be in the form of **FDR** through any nationalized bank in
  favour of the Principal District & Sessions Judge, Morena or unconditional bank
  guarantee of any nationalized bank of equal amount. The security deposit money
  will be refundable only after the expiry of the contract period. The security deposit
  will be forfeited or bank guarantee will be encashed ,as the case may be, if during
  the period of contract the services of the Contractor are found to be unsatisfactory
  in any respect.
- 4.28 The contract can be terminated by the Principal District & Session Judge, Morena, at any time, without assigning any reason, if the work of the contractor is found unsatisfactory. In this respect, the decision of the Principal District & Sessions Judge, Morena will be final and binding upon the contractor. The Principal District & Session Judge, Morena has reserves all the right to accept or reject any bid in whole or in part without assigning any reasons thereof.
- 4.29 The bills in triplicate be prepared for the services on monthly basis of approved rates will have to be submitted in favour of the Principal District & Sessions Judge, Morena for effecting payment. No advance payment shall be made against the monthly payment for the services. The payment shall be made subject to availability of the funds and no interest shall be payable for delay in payments of bills for any reason, whatsoever.
- 4.30 The job carried out shall be to the satisfaction of Principal District & Sessions Judge, Morena after getting certification from the OIC Nazarat Section, Morena failing which deductions @10% of the total bill shall be made. depending upon the severity of negligence, The Principal District & Sessions Judge, Morena reserve the right to blacklist the agency for a suitable period or from further participation in any of the jobs to be done for the Principal District & Sessions Judge, Morena. The decision of the Principal District & Sessions judge, Morena shall be final and binding on the Contractor.
- 4.31 Premature withdrawal of the tender/contract by the bidder shall make him liable for forfeiture of the earnest money/security-deposit.
- 4.32 All the pages of the tender document shall be serially numbered and duly stamped and signed by the bidder.
- 4.33 The successful Contractor shall, during the validity of the contract, engage/depute minimum one dedicated operator for each machine to operate the machines at locations specified by OIC Nazarat Section, Morena.
- 4.34 A register of surprise/routine inspection shall be final maintained by the Contractor which shall also be inspected by OIC Nazarat Section or other officer deputed, in this behalf, by the Principal District & Sessions Judge, Morena.

- 4.35 The Principal District & Sessions Judge, Morena reserves the right to review the performance wherever so desires, and also to terminate the contract at any point of time during the tenure of the contract in case the performance and the service rendered by the contract firm is found to be unsatisfactory.
- 4.36 The Principal District & Session Judge, Morena reserves the right to vary, amend or alter any terms and conditions of the tender document at the time of execution of the Annual Cleaning Contract.
- 4.37 The vendor shall depute one sweeper/cleaner at every unit of Gents and Ladies public Toilets through out the working hours on the every day and also on holiday, as and when, so required by the office of the Principal District & Sessions Judge Morena. These sweepers/cleaners shall ensure regular cleaning and sanitation 05 times per day of the public toilets.
- 4.38 The work includes cleaning of every section, every Court Room & adjacent chambers with their toilets, both judicial lockups, corridors, common Toilets, dry moping of the entire premises, stairs of every building, water dispenser platforms, parking area, Chambers of the Court Manager, Administrative Officers/Deputy Administrative Officers, Cleaning of Dustbean and building's roof top be the place of performance.
- 4.39 The employees appointed by the contractor will be duly in uniform and at least 08 employees will be present for the whole day for execution of work and to follow the instructions given by OIC Nazarat and Principal District & Sessions Judge, Morena .
- According to Letter of M.P. Finance Department No. F11-1/2023/rules/four Bhopal, Dated 31 March 2023 the contractor shall provide the names of the employees deputed for cleaning in the campus in advance and they should be provided daily wages as per the collector rates for non-technical person (Labour). The register of employees shall be maintained both by the contractor as well as the Nazarat, District Najir and in case the contractor's employees left the campus before finishing the work or specified timing the penalty shall be imposed at the rate of Rs. 200/- per head.
- 4.41 The respective **12** employees has to be deputed by the contractor for the cleaning work and they shall remain present during the court hours in the campus.
- 4.42 The concerned employees can also be deputed for other cleaning work at the campus and the contractor as well as its employees shall follow the direction of Nazarat as well as the Incharge of Nazarat.
- 4.43 Any other further conditions as well as instructions shall be leviable at the instance of Principal District & Sessions Judge, *qua* the campus maintenance and the said instructions shall be applicable alongwith the conditions already drafted in the agreement from time to time during the course of the period of agreement.
- 4.44 If the tenderer who is given the work order decides to leave the work in the middle of the contract period, he will have to give information in this regard two months in advance and will have to work smoothly as per the contract for a period of two

months. Otherwise, the entire amount deposited by him at the time of filling the tender will be confiscated.

4.45 The tenderer has to work as per he contract terms & condition during the contract period or if the tenderer is removed by the Honorable Principal District & Sessions Judge, Morena due to not working as per the contract, then that tenderer's subsequent in this order, upon agreeing to do the work on the amount payable related to the work mentioned in the contract and in case he is absent on the appointed date, time and place or does not agree to do the work on that amount, in the same continuity, the work order will be given to the next tenderer and a tender contract will be signed with him.

#### 5. Eligibility Criteria:-

The Agency/Firm applying should possess valid Income Tax PAN No. and Service Tax Account No. with GST details. The Agency should have a minimum experience of 03 years in the field of providing cleaning services.

The Tenderer must have an average annual turnover of minimum Rs. 5 lakhs during the last 03 years in the same field. **Copies of the following documents should be submitted alongwith the Bid.** 

- 1. Audited Profit & Loss Account of last three years i.e. 2021-22, 2022-23 and 2023-24
- Service Tax Registration Certificate.
- 3. Income Tax PAN No. and TIN No. (VAT Registration details)
- 4. Income Tax Return for the last three financial years i.e. 2021-22, 2022-23, 2023-24 and tumover certificate is to be submitted mandatorly.
- 5. ISO Certification for mechanized cleaning services.
- 6. Latest Service Tax Return.
- 7. Documents regarding Experience of 3 years in providing similar services.
- The Earnest Money Deposit (EMD) of Rs. 25000/- (Twenty-five thousands Only) through a Demand Draft/Fixed Deposit Receipt(Pay Order)/ unconditional Bank Guarantee.
- 9. Tender fees of Rs.2,500/- (Two Thousand Five Hundred Only) through a Demand Draft/Pay Order in favour of Principal District & Sessions Judge, Morena
- The tenderers are required to submitted the vailed certification releted to machines they are provided.

#### 6. Evaluation of Bids :-

- 6.1 The Techno-Commercial Bid and price bid will be evaluated as a package simultaneously. It must satisfy all the terms and conditions mentioned in this document and must be accompanied by all the requisite documents.
- 6.2 Filling up of all the columns in Techno-Commercial Bid and Price Bid is Compulsory.
- 6.3 Atleast three consultants are required to consider their bids for evaluation.

#### 7. Earnest Money Deposit:-

The tender should be accompanied by Earnest Money Deposit (EMD) of Rs.25000/- (twenty-five thousands) in the form of Account Payee Demand Draft, Fixed Deposit Receipt or unconditional Bank Guarantee from any of the nationalized/scheduled banks in an acceptable form drawn in favour of <a href="Principal District & Sessions Judge">Principal District & Sessions Judge</a>, Morena without submission of this, the tender will not be considered. The earnest money will be returned to all the unsuccessful Tenderer after finalization of the Tender. #### 1-PERFORMANCE GUARANTEE (Security Deposit):-

The successful bidder shall give the Performance Guarantee in the form of Account Payee Demand Draft or unconditional Bank Guarantee from a Nationalized Bank amounting to 10% of the contract value in favour of the Principal District & Sessions Judge, Morena. Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the contractor firm including warranty obligation. The security deposit will be refunded only after the expiry of the contract. The deposit is liable to be forfeited, if during the period of contract the services of the contract are found to be unsatisfactory in any respect, and or/if any of the conditions of the contract is contravened / breached, and/or towards any damage caused due to negligence of the contractor or his employees. This forfeiture will be in addition to any action by the Principal District & Sessions Judge, Morena that the contractor firm may invite upon themselves due to any of the reasons satisfied above.

#### 2-Arbitration:-

Except where otherwise provided for in the contract all questions and disputes relating to the instructions herein before mentioned and as to the quality of workmanship or materials used on the work or as to any other question, claim, right, matter or thing whatsoever in any way arising out of or relating to the contract, estimates, instructions, orders or these conditions or otherwise concerning the work or the execution or failure to execute the same whether arising during the progress of the work or after the completion or abandonment there shall be referred to the sole arbitrator as may be appointed by the authority of The Principal District & Sessions Judge, Morena. There will be no objection if the arbitrator so appointed is an employee of district court and that he had no deal with the matter to which the contract relates and that in the course of his duties as such he had expressed views on all or any of the matters of disputes or difference. The arbitrator to whom the matter is originally referred being transferred or vacated his office or being to act for any reason, the appointing authority for arbitrator as aforesaid at the time of such an office or inability to act, shall appoint another person to act as arbitrator in accordance with the terms of the contract. Such person shall be entitled to proceed with the reference from the stage at which it was left by his predecessor. It is also term of this contract that no person, other than a person appointed by the such authority mentioned above shall act as a arbitrator and if for any reason that is not possible, the matter is not to be referred to arbitration at all.
