## TERMS AND CONDITIONS OF CONTRACT

03 Year Re-filling with MAP-90% and replacement of valve and change mercurty for 209 os. ABC Modular Type Fire Extinguishers- Capacity 10 Kgs.

- 1. The firm will start working immediately after award of the contract.
- 2. Every fire extinguisher will be required to take weight at site and if the weight of extinguisher decreased by 10% & above of the original weight then it will require refilling.
- 3. The refilling should be carried out in two or three batches. (No any other extra cost i.e labour, transportation/cartage shall be paid for it in any circumstances).
- 4. Installation (including hanging hook) after refilling should be carried by successful company and number labeled of self glow type shall be used. All the extinguishers shall be fixed in such a way that the number labels are very well visible from the access point (No extra cost i.e materials, tools, labour, transportation/cartage shall be paid for it in any circumstances).
- 5. During the re-filling of fire extinguishers, if it is observed by the approved company that particular fire extinguisher/extinguishers is/are exhausted their life span or not fit to be refill; then they should carry out necessary testing on their risk and cost (no extra cost shall be paid for it) and submit technical report/ proposal for replacement of particular fire extinguisher/extinguishers.
- 6. The company shall provide a guarantee for the workmanship and material supplied/re-filled for a period of Three year against any defect. This covers all functional aspects of the product/items supplied/re-filled by the successful company including leakage of fire extinguishing agents, leakage of gas cartage and gauge, rubber pipes etc. Any replacements i.e gauge, rubber pipes, plastic horn (except cylinder) or refilling except after actual use & physically damaged, will be done free of cost by successful company as per site requirement and as approved by Bench Registry.
- 7. The rates quoted will remain valid for three years from the date of acceptance by this Registry & award of contract. The bid shall invariably quote the rate with GST for annual payment purpose.
- 8. Security deposit equivalent to 5% of the quoted rates will be deposited by the successful bidder within 7 working days.
- 9. The firm must be registered & have experience of at least 3 years in the Refilling of fire extinguisher. Proof of experience must be enclosed with quotation.

- 10. The Company shall be responsible for any damage to the equipments or laboratories equipments caused due to faulty operation/poor servicing/mishandling etc by their staff and shall rectify the defects free of cost. Decision of the Principal Registrar of this Bench Registry shall be final in this matter.
- 11. The Company shall submit monthly inspection report for visual inspection of the fire extinguisher, cleaning, checking pressure & Check safety pin, checking hose pipe etc.
- 12. The company shall prepare the list of each and every fire extinguishers with complete details i.e Location, type, capacity, Assets number, cylinder number etc and submit before the submission of bill. WITHOUT THESE DETAILS, PAYMENT WILL NOT BE RELEASED UNDER ANY CIRCUMSTANCES.
- 13. The Registry has the rights to levy penalty of 10% of quarterly estimated amount if short comings or negligence in services are reported and even terminate this AMC at any time without assigning any reason with freezing of security amount what so ever, if the services are found to be unsatisfactory.
- 14. The vendor must furnish details of GST Registration number & PAN number.
- 15. Successful bidder should submit on Rs. 500/- Stamp paper these conditions for execution of agreement.
- 16. Principal Registrar has final authority to decide the no of units to be filled.
- 17. Any dispute on terms & conditions, Principal Registrar verdict acceptable to the vendor & binding one.
